

I would like to request that Simmonds Precision Products, Inc., d/b/a/ Goodrich Sensors and Integrated Systems, (SIS-VT) Certificate number ODARF-800757-NE, be considered for continuation to perform work on Boeing programs and projects as an ODAR on behalf of a PAH (Production Approval Holder). The ODAR authorization requested is required for the execution of Export Airworthiness tags on Class II and III products. This request is also being made to help support new Boeing programs requiring certification, conformity inspections for the 787 Dreamliner.

Goodrich SIS-VT has been an ODAR approved facility for the past twelve years and maintains three Authorized Representatives under the ODAR authorization.

- 1) Boeing programs presently under production and certification, all Boeing commercial airframes 737, 747, 767, 777 all models (primary system is fuels) and present certification program is 787, approximately 300 FAA Requests for Conformity are still active.
- 2) Our fixed base of operations is located at 100 Panton Road Vergennes, VT 05491.
